You will have noted from your Newsletter that the Public Inquiry into Heron Garden Developments planning proposals for Monteagle Farm begins at Hartley Wintney on the 6th of July.

Public opposition voiced in over 500 letters of objection to the proposed development of Hill Farm earlier this year had a marked effect on the conduct of that Inquiry and we feel that it is vital to the future of Yateley that this earlier pressure must now be sustained.

Planners, Developers and indeed the Department of the Environment have been made very much aware during the last six months that Yateley has a voice and that voice has been saying loudly and clearly that we are no longer fair game for unopposed imposition of large scale development.

Certainly it takes a little time (perhaps as much as half an hour) to write a letter to the D.O.E. expressing opposition to further development. If, however, you do not wish to see every last square inch of Yateley, followed soon by Eversley and all other surrounding areas, covered with housing development, it must be done.

The attached sheet gives a number of pointers as to why we consider this proposal should be stopped, and we look to your support not only in writing yourself but in persuading your family, your friends and your neighbours to write also. Please do it now and help to show that 500 letters previously was only a beginning, not a final effort.

Don't just write - try to make an attendance at the Inquiry too, even if only for five minutes. Show that Yateley cares.
