Because of this, and of some concerns expressed at our January meeting on the issue of filming at Blackbushe, the EC took the opportunity at the relate to the constitutional aims and objectives on which the Society is based, and to ask members whether they continue to be valid, thirty years on from the founding of the Society. The members present decided that they are still relevant.

This does not mean that the EC should not inform and consult with the members, and we recognise that communication should be improved, but this is not easy when a lot of our members do not have computers, or use them rarely, and prefer to be kept in touch through this newsletter rather than by email. Also, experience has shown us that not all members for whom we have email addresses respond when contacted by this means. So any attempt at a "referendum" on a key issue by email is as unlikely to obtain a fully representative and majority result as one conducted by paper or at a special general meeting. As one member stated at the January meeting, the EC is elected to manage and shouldn't need to return to the members every time a vital issue crops up. In any case, there usually isn't time to do so, because of invariably short deadlines and a shortage of manpower. Nine of last year's EC were reelected and no new volunteers came forward.

If, as you are reading this, you are thinking "He's talking rubbish .... Why don't they ..." then please step forward with your ideas and at the very least join the PR sub-committee to air your views and also help recruit new members.

Numbers 4-10 London Road, Bagshot is the home of the Archaeological and Heritage Trust and stands opposite 'The Cricketers' pub and the residence of the Duke of Wessex. It was built originally as a Police Station in 1915 and had accommodation for Police staff as well as cells and an exercise yard for prisoners at the rear. Some of the original features still survive today. It remained a Police Station until 1981 when, after being empty for some years, John Jillings and Geoff Cole, an archaeologist, took the building on as a branch of Surrey Archaeological Society. On 23<sup>rd</sup> December 1989 a lease for 20 years was taken out for the premises to be used for Police or County use. Since then, much renovation work has been done to meet the needs of the Archaeological work performed there whilst protecting some of the original features of the building. The renovations include a wet room for washing finds, a gallery, an audio visual room used for lectures, practical exercises and demonstrations, a library containing over

2,000 books and a conservation room. On the upper floor further educational and academic work is carried out using databases.

A vast range of activities using varied methods are carried out for the education of archaeologists including surveys, research, reconstructions, publishing reports, and metal detecting. Work has been done on many major local sites as well as outside the local area and they have discovered some unique finds including items not found anywhere else in the country and the first examples of English Venetian glass. One of the earliest and most successful digs was in Lightwater where they found industrial Roman occupation on top of an Iron Age site. They also run a Young Archaeological Club, encouraging young people to become involved in Archaeology and providing them with valuable education to sustain their interest in the subject.

The Archaeological Centre has earned many awards for their work and been awarded a plaque by the Surrey Industrial History Group in recognition for saving the 'Old Police Station' by turning it into an Archaeological Centre.

Sadly, now an increase in rent to £10,500 is putting the useful and educational work being done at risk as they rely on donations.

# JUBILEE-ATIONS!

We have suggested to the Town Council that we should have a new plaque made for the Coronation Oak on Yateley Green, replacing the one which disappeared during the Church End improvements of five or six years ago. The replacing of the plaque would be timely because this year is the hundredth anniversary of the planting of the Oak to mark the coronation of George V, grandfather of the present queen.

It occurs to the Society that a double civic celebration could be created by the Council and the Society planting a new tree to mark the Queen's Diamond Jubilee in 2012.

Our overseeing body, Civic Voice, is planning a nationwide Civic Day on 23rd June 2012 and we think it would be a fitting celebration for that occasion!
